Courtesy Copies over 50 pages will incur a Large Document set up fee of .25 per page thereafter. Countrywide Process has the sole discretion to determine the fees charged for using its website or services. Fees for Countrywide Process Services may vary by location, size and service level and the amount of time spent completing service.

When authorized by customers, Countrywide Process "advances" witness and court filing fees required by court rule or statute. When customers elect to pay by credit card or open credit, a 3.25% "advance" convenience fee will be charged on witness and court fees in accordance with applicable law.

This fee will only apply to fees advanced and not Countrywide Process service fees. Customers can pay via ACH (eCheck) to avoid this fee.
